Dear Mr. Mayor,

I have received a report in which it appears that a City employee is distributing controversial material, and I thought you might care to investigate

A physician in the City has treated a woman who was a patient at the out-patient department of the Gouverneur Hospital. There she was handed a copy of the Catholic Weekly and in its folds was the Social Justice magazine. It is further reported that these were distributed by a Miss Thompson who is the houskeeper at the hospital. The magazines were forwarded to me with the report.

May I ask that if this report is true, is it a proper procedure for the hospital, and if so may other organizations arrange to distribute their material?

The average layman may regard the duties of hospital employees to be such that are devoted to the management of the hospital and care of the sick and needy, and not the distribution of printed material designed to influence others to their way of thinking.

I hope I am in order in bringing this to your attention, and that it will be convenient for your to reply.

Dttention Miss Fredman, Dear Miss Fredman

Referring to my 'phone conversation of this A H I am enclosing the clipping in which Senator Lundeen of Minnesota spoke at a dinner of the German-American Board of Trade.

You may recall that on April 23, 1939 a Treasury Department ruling went into effect directing a 25% penalty on merchandise imported from Germany thru Barter arrangements. It must be remembered that Germany for years has not been paying for her purchases with <u>free</u> money but really thru I.O.U'S. These I.O.U'S can only be cashed thru purchasing German merchandise and as an inducement to our businessmess to accept this arrangement, they have been offered subsidies in some cases as high as 50%.

This country has union wages, short working hours and high standards of living. Germany has abolished unions, increased the working hours hence her products are produced at prices highly competitive to American industry. It isto protect our workmen and industries that the 25% Treasury Department ruling went into effect.

To further explain the effects of Germany's method of paying for her imports with BLOCKED Marks (marks good only in Germany), last year Chile wanted to buy 65 Airplanes and her army recommended American planes because they were better. But Chile bought them in Germany because she had a lot of blocked Marks. Similar arrangements resulted in the shop windows of South America being flooded with German radios, refrigerators, electrical goods and house furnishings.

The only things Germany is interested in buying from this country because of her shortage of foreign exchange and her inability now to get all the raw materials she needs, are oil, copper, lard, fats and wheat. In exchange we must take her manufactureed goods.

In conclusion, one may say the Senator should remember and point out that were Germany able to pay in sagotiable money he would have a

reason for urging more trade with her, but under the circumstance, aside from the moral reasons for boycotting this aggressor Nation, he is advocating something dangerous to both the American workman and businessman.

In my estimation we have reason to mark this Senator pro-Nazi and watch his future activities.

Please let me know what, if any action, National takes on this.

At a meeting attended on Sunday, March 31st, 1940, 2:30 P. M., at Pythian Temply, the Non-Sectarian Anti-Nazi League, I present the following report:-

The meeting was opened by the singing of the Star Spangled Banner.

Dr. Dubofsky welcomed all present and then eulogized the late Samuel Untermyer as the first influential man to fight naziism, not only in the United States, but all over the world; that on the surface, Dr. Dubofsky said, everything seems to be quiet, underneath, however, a volcano is brewing and he feared in the very near future there would be many more equitions than we are having now; that 7 years ago Hitler 1st declared his boycott against the Jews; that the boycott was not started by the Jews against Germany, but by Hitler against the Jews. was finally through Mr Untermyer's efforts that America recognized the only effective weapon to be boycott of German goods; that the Nazis have succeeded in organizing and financing a large number of organizations who are spreading the doctrine of hate against our people, they are following the nazis step by step and in one large city they called upon their listeners to destroy the Jews. A large organization is being formed to begin an economic boycott in New York State in the name "Buy Christian." This summer there will be public meetings at which there will be gangs who will attack every Jew; things will go on just as they did in German and we in our organizations must do everything in our power to prevent this.

The next speaker was Prof. Max Winkler, and economist. He said the argument always has been that if there were no Versailles. there would be no Hitler; that no one would raise this criticism if they had read the document. Two provisions were: 1 - the Germans were adjudged guilty of having caused the war; they admitted their guilt; this hurt their pride. 2 - Inasmuch as Germany is responsible for the war and the damage done, Germany agreed to make good. This caused the Germans much concern. Now to make good Germany borrowed the money and they borrowed \$1.84 for every dollar they paid; Germany then repudiated these debts so that reparations were paid by the countries who loaned them, Germany making .84 on each dollar besides. He then showed the difference between Democratic countries and those of the dictator. a democracy the conference precedes the deed. With a dictator the deed precedes the conference. Germans are only impressed by deeds. He then outlined the various concessions made to Germany and their results. All reparations were finally wiped out but nothing could keep from the German mind the thought of their defeat in the World War so this was was inevitable. Germany is in an era of conquest and until that instinct is destroyed there will never be peace.

The next speaker was a Mr. Baumann, an investigator who reported in detail with reference to the various Christian Front and Nazi activities in this country. He promised shortly to publish some startling statements now in the possession of the FBI which could not at present be told. He informed us that our enemies were even getting ready to form the American Union Party and nominate for the assembly in the Bronx a man named Casterman. He told us that the greatest danger camde from the Klu Klux Klan; that in past years it has always reached out for its membership to 3d 4th & 5th generation Americans - no foreighners; that now this Klan includes all these antisemitic groups and they are forming a strong national federation. Passaic the Klan held a joint meeting with the German American Bund at which there were a representative of the American Fascists. Burning crosses were placed in front of synagogues. These moblizers will have their first open meeting May 1st -- outdoor meetings in Greater New York. At each meeting they will have only trained platform speakers and an additional feature will be a sound truck equipped with messages from Joe McWilliams.

The next speaker was a Mr. Malkinson the editor of the Jewish Morning Journal. He strongly urged that influential men and worman of our race contact and entertain editors of leading English papers. He felt strongly that our best medium was the newspaper.

He was followed by the Secretary for the legal staff of the Anti-Nazi group. He reported in detail what had been done. His closing remark was that he wan an Austrian who had found refuge in America. "But after America; what."

My idea is that the meeting was called to impress upon all delegates the strong need of financial support so that the representatives of the League could work strongly against these evil influences.

NAZI OUTPOSTS IN THE UNITED STATES

With the exception of the origin and growth of the German American Bund, Nazi philosophy and activities in the United States rarely predate 1933, when Hitler came to power. But since that time, not only have German American groups swung over or been taken over, but the United States has seen the growth of two other types of Nazi groups - the native Fascist and anti-Semitic groups.

Anti-Semitism has been and is of course, part of the stock in trade of the Nazi party in Germany. By means of the smokescreen of anti-Semitism, the Nazis were able to grow and to take over power even though they were a one-third minority of the German people. This demonstration of the value of anti-Semitism as a political weapon was not lost upon the host of malcontents created by the economic depression that began in 1929.

All this time, the Nazi government in Germany was rearming in violation of treaty agreements and in 1935 began its military march with the occupation of the Rhineland. To detract from what it was doing it stimulated disruptive activity by pro-Nazi organizations in other lands, including the United States. Through World Service, the official German propaganda medium, the Fichte Bund, the Auslands Institute, and numerous other agencies, came a steady flow of information, advice and propaganda. Through the offices of consuls in the United States came encouragement, both real and spiritual. And through willing or merely stupid individuals in the United States, the Nazis in Germany stimulated and guided myriads of organizations to act here as its agents or as its apologists.

German American organizations in the United States before 1933 represented in the main genuine cultural units centered about the German origins of their members.

Although there was an awareness of the difficulties in which Germany was finding itself as an aftermath of the World War, the primary loyalties of these groups were with the United States. Whatever regrets may have existed for the economic and political depression of Germany were mitigated by a certain feeling of pride in the knowledge that Germany was experimenting with a democratic form of government.

But within Germany itself the Nazi movement had been growing steadily since the early 1920's. Hitler's movement was a minority, but a highly organized minority. And true to the ideas set forth in Mein Kampf - the Nazi movement began to spread its tentacles abroad even before it came into power in Germany.

In the 1920's Hitler sent his emissary, Kurt G. W. Luedecke, on a tour of the United States. Luedecke's purpose was twofold - one, - to secure financial support for the Nazi movement in Germany; two, - to convert German American organizations to Nazi philosophy and ways. He was successful in neither, as he explained in his book, "I Knew Hitler." But in the 1920's a Nazi emissary in the United States did not have the power the Nazis themselves were able to wash directly from Germany after 1933.

Luedecke's failure, however, does not mean that the Nazi party of Germany was without an American branch from its earliest days. Among the other German American Societies in the United States in the 1920's, there was the Teutonia Society of Chicago, as Nazi as Hitler himself. Founded in 1924 under the leadership of Fritz Gissibl it sent contributions to Hitler from the very outset. In 1929 another Nazi group was organized in Detroit by Heinz Spanknoebel, who was then employed, along with Fritz Kuhn, in the Ford factories. An attempt by the members of Teutonia to effect an amalgamation of the two groups resulted in their coming off second best. Realizing the value of a united Nazi movement in the United States, Spanknoebel went to Germany, joined the Nazi party, and returned in 1932 as the full blown American Fuehrer. At this juncture,

American Hitlerites were divided into two groups. The one was known as "Lagru," that is,
"Landesgruppe (regional group) U.S.A. of the National Socialist German Labor Party;"
the other was an organization expressly set up for American citizens of Hitler tendencies, known as "Friends of the Hitler Movement."

After Hitler came to power in 1933, these groups were merged into one organization, the Friends of New Germany, with Spanknoebel as its head. For reasons of diplomacy it had been decided by Nazi party officials in Germany not to call the American Nazi group the branch of the National Socialist German Labor Party. After Spanknoebel fled the United States upon his indictment by the Federal government for having acted as an agent for the Reich without being accredited to the diplomatic service, Fritz Gissibl and Dr. I. T. Griebl succeeded to the leadership of the Friends of New Germany. Subsequently Gissibl was forbidden re-entry into the United States as an undesirable alien and in 1938, Dr. Griebl fled to Germany as a result of Nazi espionage disclosures.

Prior to these developments, however, Fritz Kuhn, Gissibl's former co-worker in Detroit, became head of the Friends of New Germany on December 1, 1935. On June 3, 1936 the name of the organization was changed to the Amerikadeutscher Volksbund - the German American Bund.

The German American Bund is the mainspring of the Hitler movement in the United States. It and the organizations out of which it grew go back to the beginnings of the Nazi movement in Germany. About it clusters a swarm of subsidiary groups, organized for specific purposes. The result is a sort of holding company structure.

Old German American Societies have been brought under Nazi influence, if not domination, in large numbers. Through threats to wreak vengeance upon German relatives of German Americans, Nazi agents have been able to insinuate themselves into positions of importance in many groups. And even where they have failed to gain entry they have secured the subservience of these groups by means of the same threats. Other German American groups, of course, have gone over to the Nazi side without coercion. They simply came to believe in Nazism.

There is included in this memorandum a list of Nazi outposts in the United States. For the purpose of convenience, the organizations are divided into the categories of Nazi, Native Fascist, Italian and other foreign Fascist groups, and Coughlinite. In their method of operation, however, they cover more ground than is indicated merely by the general nature of the category noted.

#### NAZI GROUPS

Some of the groups in this category are frank in their espousal of German Nazism. They openly use Nazi propaganda sources. Other groups take no such affirmative stand, but close examination of their activities and literature reaches the same conclusion. At the other end of the scale are the groups that profess to be purely pro-American, but are controlled by known Nazi advocates.

## NATIVE FASCIST GROUPS

Organizations in the United States whose philosophy or propaganda can be traced to Nazi and Fascist sources do not in all instances admit, and sometimes may not realize the source of their inspiration, nor are they always readily identifiable for what they are. In this category are many organizations which possess a seeming respectability in the eyes of the American people. Some would deny any intention to serve the interests of Nazism here. They are listed because known Nazis or Nazi disciples have frequented some of their meetings, because some of their literature has been approved and disseminated by Nazi organizations and because in some instances officials of these groups or other persons active in them have made statements that can be readily construed as exported Nazism, or are active in groups more readily censurable. Some of the organizations have consistently followed the line currently advocated by Nazi propaganda agencies in Germany. In so doing some of them may have been motivated by what seemed to them to be purely patriotic considerations, yet the effect of such activity on their part has been to acclimate American public opinion toward a receptiveness for Nazi and Fascist philosophy. Other groups have consistently worked against the best interests of our democratic republican form of government and have often shown slight regard for the liberties guaranteed by the Constitution. Some have continually flauted the age-old American concepts of tolerance and sanctuary from persecution. Some pretend to be anti-Communist. Others may attempt to cloak their activities under the guise of being political or patriotic groups. Many have utilized the technique of including the word 'Christian' in their name.

## ITALIAN AND OTHER FASCIST GROUPS

The groups in this category do not, on the whole, owe their establishment to the growth of German fascism. They do, however, give first allegiance to foreign fascist lands and organizations, and their activities, like those of all fascist groups in the United States, reflect the magnetic attraction of the Nazi successes.

#### COUGHLINITE GROUPS

Organizations listed under this category have been as flagrant in their espousal of Mazi philosophy and propaganda as any other groups listed in this memorandum. They are truly in a class by themselves and they partake in equal measure of the worst characteristics of the Nazi, Fascist and anti-Semitic groups. They owe their inspiration to the activities of Father Coughlin, for he is their patron saint. From him they have borrowed the cloak of religion to cover an anti-religious crusade. Many of these groups functioned in a manner reminiscent of Storm Troopers in Germany, even though Father Coughlin may have disclaimed from time to time any intention to create civil strife in the United States. It is with the organizations that make up this group that most of the persons arrested for anti-Semitic street disturbances in New York City in 1939 were connected. The main organizations in this category are the Christian Front, the Christian Mobilizers, the American Citizens Committee, the Committee for the Defense of American Constitutional Rights, and the National Union for Social Justice. The other organizations listed are almost all merely names adopted by members of the main groups for a particular function or purpose

I suppose you have noticed the investigation going on of the drug companies with the attempt to show German control. What they mean, of course, is the I.G. Fabrenindustrie.

Do you recall about two years ago, I made an analysis of Agfa Anaco showing the trade murk owned by the German company. From this analysis we found the interlocking of several companies, WINTRHOP being one, with the American I.G. Chemical Co. I have within my files a wrapper that the American made Agfa film is wrapped, and one in which the German film is wrapped. They are identical in design and color, except for a few words.

Would it be worthwhile to write Washington and tell them of our investigations, if only as a gesture to show that we understand the situation.

I should be very glad to meet with you and make up a report that would have sufficient weight.

Somewhere in my file I have original bills of lading showing shipment of drugs from Germany to the Schering Corp. I tried to find them just now, but that's always the way with one man research bureaus, - can't find things when you need them most.

Please let me know what you think of this.

ANTI-NAZI LEAGUE SEEKS ACTION AGAINST DISCRIMINATORY CONCERN WHICH ADMITTEDLY REFUSES APPLICANT BECAUSE OF RELIGION; COMPANY TO ANSWER SUMMONSES TODAY

The Non-Sectarian Anti-Nazi League has sought redress in the courts for the victim of what the League's chairman today described as one of the most blatant examples of discrimination ever to have come to its notice.

The League has been conducting a campaign against discrimination because of race, color or religion, charging that such discriminatory practices smack of Nazism and have the effect of impeding the united war effort by all elements of the American people against Nazismo

Isidor Rosenstock, 701 West 180 Street, New York, was sent out by the United States Employment Service in response to a request by the Shelter Island Oyster Co. for a cashier. Interviewed by the company's manager, Rosenstock was informed that the concern does not employ Jews.

On a card provided by the United States Employment Service, the manager wrote as the reason for rejecting the applicant, Mr. Rosenstock, "RELIGION".

Julius L. Goldstein, attorney and chairman of the League's executive committee, has been designated by the League as counsel for Mr. Rosenstock, who has sworn out summonses under the Penal Code against the Shelter Island Oyster Co.

The summonses are returnable today in Essex Market Magistrate's Court, under Sections 580 and 700 of the State Penal Code, which provide penalties for concerns discriminating against applicants for employment on the basis of race, religion or color, particularly where contracts involving war supplies are concerned. This apparently is the first case to be brought under these Sections: in which incontrovertible documentary evidence as to facts could be presented, and the League hopes, through this action, to establish the extent to which criminal penalties may be invoked under New York statutes in cases of this type

Mr. Rosenstock is

the father of three sons, 18, 14 and 4. The eldest is in City College on a scholarship; the fourteen-year-old attends Brooklyn Technical high school.

The U. S. Employment Service, at 10 East 40 Street, was not aware of the discriminatory practices of the Shelter Island Co. when it sent Mr. Rosenstock out on the job, and a spokesman explained to a League representative that it would not service the company any longer.

Professor James H. Sheldon, administrative chairman of the Non-Sectarian Anti-Nazi League, asserted today that "this case is one of the most blatant examples of discrimination ever to have come to the notice of the Anti-Nazi League. It is in direct violation of our war policy as enunciated by President Roosevelt, and is an example of how man-power is being wasted by unpatriotic individuals. Morally and politically, discrimination because of race, religion or color is a direct surrender to one of the worst of Hitler's doctrines, and in addition, such practices have the effect of slowing down production and impeding a united war effort by all elements of the American people against Nazisme"

ATTEMPT TO USE SEDITION TRIALS AS NAZI PROPAGANDA SOUNDING BOARD LIKELY TO BE MADE, ANTI-NAZI LEAGUE WARNS

That an attempt will be made to use the forthcoming trials in Washington of the 28 individuals held on sedition charges, as a sounding-board for the dissemination of Un-American propaganda is the warning of the Non-Sectarian Anti-Nazi League which yesterday transmitted evidence of such a plan to William Power Maloney, special prosecutor in charge of the trials for the Department of Justice.

At the same time, the L eague issued a statement calling upon the press and radio news agencies of the country, to be on guard against an attempt by the defendants to plant anti-American propaganda, introduced as "evidence", into the news columns.

The League pointed to a copy of a leaflet which has come into its possession, written and signed by E.J. Garner and Son, in which the pair assert that "the trial will be an event of great historical importance and will bring the Jewish issue 100% out... Who knows but... the Protocols of the Wise Men of Zion and other writings some known and others unknown to the public..." (will be introduced).

Garner, who is one of the 28 to be tried, was the publisher and editor of "Publicity", a semi-literate weekly newspaper published in Wichita, Kansas, which, until barred from the mails, was filled with Mazi propaganda and anti-Semitic diatribes following the Mazi line, Garner was shown to have connections with the German Railways information office, a Mazi propaganda and espionage outlet in this country, Writers for Garner's newspaper-included Edward James Smythe and Colonel E.W. Sanctuary, anti-Semitic and anti-Catholic pamphleteers.

In addition, the League reported that its investigators had discovered a more or less concerted plan among several of the defendants to use the trials in the same manner for purposes of propaganda dissemination,

The Anti-Wazi League advised Maloney that its reports indicated that "many of the individuals on trial expect to make long, vituporative speeches, already being prepared, attacking the Government and the war, which they expect to be reported in the nation's press in detail. Anti-semitism, in line with Nazi propaganda technique, will be stressed.

"Just as many of the nation's newspapers unwittingly fall prey to Nazi propagandists abroad who send out stories which they hope will be used by our press, so do many of these 28 individuals and the people behind them hope that our newspapers may be tricked into running their loud-mouthed lies and innuendoes. The plans of some of the 28 call for exploiting any such propaganda possibilities to the full limit."

ANTI-NAZI LEAGUE APPEALS TO MCNARY TO PLACE REPUBLICANS BEHIND ANTI-POLL TAX LEGISLATION; DENOUNCES FAILURE OF SENATE TO PASS LEGISLATION

A last-minute appeal to Senator Charles L. McNary. Republican floor leader, to place the Republican members of the Senate behind the anti-poll tax legislation, was made yesterday by the Non-Sectarian Anti-Nazi League.

In a wire to McNary, signed by Prof. James H. Sheldon, chairman of the Anti-Nazi League, the Republican leader was urged to "throw the full force of your support behind the vote for cloture on anti-poll tax bill.

"Senate rules make it clear that one vote against cloture will aid opponents of this measure more than would two votes against the bill itself. Millions of voters all over the country now stand aghast at printed reports that you are placing the Republican group in the Senate in opposition to the stand jointly taken by both President Roosevelt and Wendell Willkie. We feel confident that these reports will turn out to have been ill-founded."

Commenting on the Senate's failure to pass anti-poll tax legislation,

Professor Sheldon described the tax as "an instrument cunningly devised to pervert democracy by short-circuiting the voting and making it possible for the minority to rule. It is a mechanism consciously planned to rob the common people of the South of the rights which the Constitution sought to guarantee to them.

There can be no legitimate question raised as to the constitutionality of this bill, and efforts to raise such a question are only a camouflage for dark and dictatorial minds. Congress has always had and exercised the admitted power to regulate Federal elections so as to prevent graft at the polls, and the poll-tax is merely the biggest example of such graft.

The apparent failure to get rid of this nefarious perversion of the democratic process is disgraceful at a time when we are fighting on the battle-fields throughout the world to preserve our democracy — and if the efforts of Bilbo and his friends succeed they will deserve a Nazi medal as reward for services rendered our enemies.

ANTI-NAZI LEAGUE SENDS MESSAGE OF SUPPORT. TO WISE ON OBSERVANCE OF MOURNING FOR JEWS

The observance of yesterday by the Jews of America as a day of mourning and prayer for the millions of Jews in Europe already slaughtered or threatened with extermination by Nazi Germany evoked a message of support and sympathy from the Non-Sectarian Anti-Nazi League.

Prof. James H. Sheldon, administrative chairman of the League and former member of the faculty of Boston University, sent to Dr. Stephen S. Wise, leading sponsor of yesterday's observance, a message expressing the Anti-Nazi League's "profound sympathy for the Jews of Europe who have been forced to bear the brunt of the Nazi terrorism".

The text of the message follows:

"The Non-Sectarian Anti-Nazi League sends you its profound sympathy for the Jews of Europe-who have been forced to bear the brunt-of the Nazi terrorism. Americans of all faiths join with the Jews of America in mourning for the inhuman slaughter of these defenseless men, women and children.

"But Americans of all faiths are determined that the scourge of Hitlerism be removed forever from the earth — not only because of our natural horror at the persecution of these defenseless people, but because we realize that such persecution is merely a devilish device used by the Nazis to further their plans for world conquest.

"Through anti-semitism the Nazis seek to gain sympathizers on the basis of a common hate. Now that they are failing on the battlefield and weakening on our home-front as well, they are taking the course which one expects gangsters to follow: torture and abuse of all those who cannot fight back.

"When the Nazis, by these barbaric excesses against the weak and defenseless and against the righteousness of God, reveal their unter contempt for the dignity of man, they make it transparently clear that this war is a war of all the forces of evil met together against the bulwark of Christian civilization, which stands above all else for the value of the individual and the dignity of the human soul.

"Be comforted in the fact that the Jews who have died and the God-fearing people of Protestant and Catholic faith who have borne the same persecutions, have not died in vain. We shall all remember their sufferings in the new world to come and they shall not be forgotten."

Memorandum to Women's Division:

All women are naturally sympathetic with anti-Mazi and anti-Mazcist activities. Thatever their creeds or social attitudes, the degradation of womanhood under Mascism has roused them to resentment. The elimination of German and Italian women from commercial, political and cultural life need only be presented to secure the support of American women. Those women who like to engage in pro-democratic work during the day should be organized into special women's divisions. In general, the women's divisions could concern themselves with the following activities:

- 1. Arrange social functions, entertainments, lectures etc. to provide funds for educational and other anti-Fascist activities.
- 2. Develop their own speakers' committee and send their members to address wemen's organizations throughout the city.
- 8. Wetch neighborhood activities of Pascists and similar groups in their communities.
- 4. Analyze political trends particularly anti-liberal and reactionary in their neighborhood.
  - 5. Watch for discrimination in defense industries.
- 6. Make it clear to other woman, by all means at their disposal, that the winning of the war does not secure the right peace.
- 7. Help in the boycott against the "newspaper axis" by spreading the boycott against these newspapers.
- 8. Help in the distribution of leaflets which from time to time are prented by the national office.
- 9. Organize their own paper for the purpose of using this paper for the education of women throughout the country.

- 10. Try to establish the Council of Women's Organizations for the purpose of working for the better understanding between human beings and to interfere in racial discrimination.
- 11. Wathch that our government is not forced under the pressure of reactionary circles in this country into a peace with the Axis.
- 12. Establishment of open forums which are to discuss current events and have speakers present the different views. Participate in these forums.
- 13. Try to educate younger people in schools through their parent-teachers organizations and teachers' unions.
- 14. Be helpful as volunteers in the offices of the national office.
- 15. Try to create women's unions throughout the country.
