The first monster rally of the Brave Women's Division of the Amer. League for the Defense of Jewish Rights was held Wednesday afternoon Nov. 29, 1933 under the leadership of Mrs. Edna Crane & Mrs. Louis Myers.

The purpose was to acquaint the ladies with the conditions which confront all the Jewish people as well as all the women in Hitler's Germany today, and to unite in protest against these atrocities through a well organized Boycott of all German made merchandise and all German ships until such time as Hitler will see fit to set the clock forward again to 1933.

Mrs. Edna Crane presided calling first upon Mrs. J. B. Pincus who accompanied by opened the meeting with "The Star Spangled Banner" followed by the "Hatikvah". This was a very impressive beginning of a very interesting afternoon.

Mrs. Mark Haines, the National Chairman of the Women's Division then outlined in detail some of the hideous offenses against our people in Germany, and the purpose of the League to help combat them.

Mr. Anna Hochfelder was the next speaker, and she, too, very ably gave a vivid description of the Naziland and its tactics.

The great speaker of the meeting Mrs. Letcha Kebab delivered a masterful oration on unity and brotherhood of the General race, laying stress upon the words, "that when a Jew is scratched on the other side of the ocean the hearts of his brothers Jews here bleed." She, too, described the medieval barbarism of Germany today and convinced those present that the only effective weapon with which to strike Hitler is thru the pocket book, the Boycott. She also stressed the importance of being well organized to check the Nazism which already is rampant in this country.

Mrs. Myers urged the ladies to unite in the boycott of German merchandise and in a boycott on all stores which persist in handling and displaying German merchandise.

Questions on the floor were answered by Mrs. Harris who also called for membership

to the League. The dues were to be \$1.00 per year to make it possible to have a large membership.

The following women enrolled and paid their dues. Twenty-five dollars was collected and turned over to the American League for Defense of Jewish Rights by Mrs. Myers. The new members are

The second Bronx meeting of the League was called to order at 2.45 PM at the home of Mrs. Myers, 1605 Walton Cr. Jan. 17, 1934

Acting as Chairlady Mrs. Myers informed the ladies present of the change of name of the organization to the Non-Sectarian Anti-Nazi League to Champion Human Rights.

The minutes of the previous meeting were read and motion made & seconded that they be accepted.

Mrs. Myers then told of new atrocities being perpetrated on the Jews in Germany. Also of the spreading Nazi propaganda in this country. She read a letter being circulated anonymously calling upon the gentiles to boycott all Jews here.

A discussion then followed of ways and means to strengthen and spread the boycott against all German made merchandise.

A motion was made by Mrs. Corie that committees be appointed to go to the various organizations and spread our purpose - the boycott. Motion seconded.

Mrs. Myers then appointed every member present as a Committee of one to bring home to her respective organizations our purpose and ambitions.

She also suggested that the ladies visit their neighborhood stores and ascertain whether they carry German made goods reminding them that by so doing they will surely endanger their Jewish patronage.

Discussion followed and the ladies were apprized of some stores still carrying German made goods, among them R. N. Macy - Gimbel, Albrechts, Paris Curtain Shop - & Kayers menshander.

It was decided the next meeting to be held on Jan 31, 1934 at 563 E. Fremont Ave (Miller Bldg). This meeting place was offered to the organization gratis by Mrs. Fruchman, Pres. of the Ladies Auxiliary of the Friends of Zion, who held their meeting there.

AS FREE CITIZENS   
and freedom in Germany.

Report of Conference held at Hotel Plaza by  
Non-Victorian - Anti-Nazi League <sup>for the Champion Human Rights</sup> Jan. 29, 1934 - 2:45 P.M.

Mrs. Harris - the National Chairman opened the meeting. She introduced Mrs. Julius Herber, Chairman of the Manhattan group - who took the Chair and stated the purpose of the conference - to report individual experiences, to discuss general problems, new moves, and so to carry back to individual groups, inspiration and new ideas. As an aside she said her group of the Physicians wives - sends out a bulletin each month to 500 members.

She reported the heartening news of Germany's inability to pay interest on her bonds, due to the 37½% falling off in exports.

Mrs. Rebekah Kahut was the next distinguished speaker. She questioned how anybody could be happy here hearing of the things happening in Germany. She cautioned against believing any of Germany's promises. She related finding an old history she studied when a young girl and in it Germany was then looking forward to "der Grosser Tag". It indicated war preparations of 30 years. She also said a few pointed words on women who volunteer to work and then do something only when they feel like it. This she said is not honest or decent. Volunteer work

she emphasized, carries a great obligation. In closing she stressed these remarks...

German Psychology has not changed. If we win this war, we win it for the Laboring party of Germany - for minorities & mankind.

Mrs. Mason who next spoke, electrified the meeting with her report - which dealt with the action of the Federation of Jewish Women's Organization in refusing to endorse a tabling a resolution endorsing the boycott. A Petition of Protest was voted to <sup>be</sup> sent to them, with an amendment to it to carry the names of all the organizations present.

Mrs. Richard Gattner who recently returned from France told of her work abroad with gentiles and French Jews. She told of being asked what are the American Jews doing, and on her return finds the Federation of J. W. Org. refusing to further the boycott. She became very agitated and called shame - shame shame on those women present and absent who dared to offer dissenting views. She almost shouted "We should have no honor if we did not fight for the Cause - In working for the boycott

we are defending our honor and we are helping Germany because of the thousands there who dare not open their mouths.

The next speaker told of a Conference to take place Sunday regarding the question of holding the World Olympic games in Germany. A motion was made and duly carried to send a protest against having the games in Germany.

A report was also made of a new youth movement called the Vigilantes. The young members are to go from store to store asking questions regarding the amount of German goods bought - sold - and amount they buy. The idea to be spread - is that there is no market for German goods.

Another prominent speaker was Estelle Stemberger - International Secy of the American Peaceways. Add omitted Paragraph over

In Conclusion I would like to say that no one who had been present could leave the assembly without feeling inspired by the sincerity, burning enthusiasm and splendid showing of these loyal Jewish women.

January 30, 1934

at the 14th Annual Convention of the Federation of Jewish Women's Organization, after a sharp debate - the delegates indorses the boycott.

Fiorullo La Guardia spoke as Vice President of the Non-Violent Anti-Nazi League and Mayor of N.Y. City.

He said - To be against Hitler is to be for the people of Germany. To be against Hitler is to be for the Peace of the World.

The last move of the Conference was to appoint a Committee composed of Madames Fisher Harris Hattick Stern Mason, to be present at the Convention the next day and to present our petition & see that it was not tabled.

Feb. 14, 1934 (Jan. 31)

The meeting was called to order by the Chairman Mrs. Myers. Minutes <sup>of Jan. 31</sup> were then read by the secretary and accepted as read.

For the benefit of new members the purpose of the organization was retold. They were also told of the Research Dept. the League maintains to investigate fraudulent markings on goods coming in from Germany. Also its ability to find new sources for buying merchandise similar to what Germany exports.

The Lydings resolution was brought up and members urged to write or wire their support of this Congressman's splendid interest efforts in our cause.

Open discussion was then held concerning ways and means to raise money.

Motion was made by Mrs. Truckman, seconded by James Miller + Resenthal that we have a Board. Chairman appointed is Mrs. Truckman, Co-Chairman James Lipschutz, James Miller, Harris J. Levine, Celia Fuchs + Messeloff. Donations of merchandise may be sent to 729 Seventh St. Further details to be developed.

A card party was next discussed and settled by motion of Mrs. Celia Fuchs and seconded by Mrs. Corio. Mrs. Levine suggested.

that she may be able to supply cards & letters  
Miss Fuchs & Levine and the Chairman  
all arrangements being left in their hands  
and to be completed for the next meeting  
so that we can distribute tickets immediately.

Open discussion ensued on the  
cooperation of some stores with our boycott.

Mrs. Lipsky displayed a coat purchased at  
Arnold Constable solely thru our report of their  
working with us. She also brought her Cousin who  
made a like purchase.

Mrs. Jas. Miller displayed a purse purchased  
at that store.

Mrs. Schubert relates an incident where  
her daughter went to buy paints in Macy's and  
the saleslady made an effort to interest her in an  
American product, saying they no longer had  
German paints. This is an encouraging sign  
altho as Mrs. Sam. Miller pointed out - Macy still  
retains their buyers office in Germany.

A report was made by Myers of the  
convention she attended of the Federation of  
Jewish Womens Organizations. It was very  
interesting and dramatic with the appearance  
of Major La Guardia - Vice Pres. of our League

As the resolution was finally adopted by that organization to Boycott German Goods, a victory was won and "All we want that ends well"

It was suggested the secretary write to Mr. Leberman of Arnold Constable informing him of the new business he received from some of our members.

Mrs. Myers also related an interview with the buyers of China at Sterns Dept store. They are not buying anything from Germany and expected to be sold out entirely of any stock they had after their January sales.

Minutes of Special Meeting March 5

Previous minutes of meeting accepted as read.

Mrs. Levine as Chairman of the Bridge Comm. then gave her report. She reported that 206 tickets had been sold - expenses amounted to \$21.55 leaving a profit of \$63.95. Everybody was very pleased with the report and with the work of the Committee. Mrs. Levine & Trachs and they were given a rising vote of thanks in full appreciation of their enthusiastic work.

Mrs. Myers then gave a report of the testimonial dinner given to Wm. Grein - Pres of the Amer. Soc. of Labor. Later she read extracts of the speech of our Pres. Paul Antermeyer sent to be read that night.

She also reported on the bridge party of Mrs. Mason Bray group. Mr. Sol Rubin - Judge Advocate General of the Jewish War Veterans Club spoke at our Bridge then the influence of Mr. Mark Cook - Commander of Jewish War Veterans Bray Post 64 - also spoke at Mrs. Mason Bridge and was most enthusiastically received.

He reported the new legislation effective May 1 making it unlawful for any goods coming from Germany being marked in any other way than Germany. This legislation will now

do away with the subterfuges they have been using such as Rheinland - Saxony - Bavaria etc so that unsuspecting people not well up on their geography will no longer be deceived.

Mr. Rubin also reported an amendment to the Civil Rights bill. ~~Making~~ it unlawful and punishable by prison sentence for anyone to send or utter propaganda or to slander. This amendment provides that dissemination of propaganda which subjects any group of people to shame, hatred, ridicule or contempt is a criminal offense punishable by fine or imprisonment.

It is indeed heartening when we find such men as Mr. Rubin laboring successfully to give us the lasting protection of the Law.

The good news was also reported that Ads 34<sup>th</sup> and Hearns have joined the boycott.

In discussing our proposed Rally for April Mrs. Julian was asked to sound out Edmund Brown if he would play for us - and Mrs. Modell as regards her brother who is a fine <sup>violinist</sup> pianist & incidentally married to the sister of Jacobus Heffty.

Mrs. Myers then placed before the meeting tickets for the concert at Carnegie Hall.

Several members reported seeing quantities of German goods in stores & Macie's so the members are requested to be vigilant when visiting these stores, even tho they have joined the boycott.

Reports were made of incidents concerning the New Mount Hotel & Schrafts. Both these places have plainly expressed themselves as not wanting Jews - These reports are being investigated and members are advised accordingly. In the case of Schrafts they are reported to have written a letter advising they do not care to have Jewish organizations conduct any affairs there.

The New Mount hotel apparently deliberately erred in the serving of a dinner <sup>menu</sup> for which a written contract was made. When asked why they spoiled and did contrary to the dinner ordered, they are reported to have said - they don't want Jews there anyway.

A report was asked <sup>sent</sup> for by Horatio Leaven on the concert tickets.

In order to check up as much as possible in view of the closeness to the concert date it was decided to have a special meeting so that money and tickets may be fully accounted for and unsold tickets returned to the League.

A letter was read from the Research Dept of the League regarding the German hops in beer. The Law has passed our board of censorship. They are 100% American. Schaefer Brewery referred the letter to a Board of Trade that has not answered. This evasiveness leaves the beer open to questions since they have given no answer either way they are on the questionable part.

A letter was also read from R. H. Macy to a customer who had closed her D.A. on account of their buying German goods. Macy explained that they had closed their Berlin office on account of consumer resistance and their orders to Germany decreased 97%. Whereas in Feb. 1933 they bought \$127,516 from Germany - this year in Feb. they only bought \$2,830.

They also wrote they do not consider it good wisdom for a department store to engage in boycotts. They believe and individuals can refuse to buy goods for any reason they want to, but a department store cannot refuse to supply goods for which a demand in any degree exists. They also add they have endeavored to find

substitutes for German goods in domestic & other markets and have been successful with few exceptions.

Members are advised to watch for the displays of German made at Macy & refuse to buy it.

Mrs. Coates presented correspondence from the Sachs furniture Co. concerning a date for a card party. They are ready to give May 23. - They supply seating arrangements and a door prize - will also print announcements. Should we desire they can make arrangements to supply coffee & cake at 15¢ per person or ice cream at 10¢.

As many members thought May 23 would conflict with the Washington Heights card party - a committee was appointed consisting of the well known team of Levine & Fuchs - to interview the Sachs people & make whatever arrangements advisable.

Representatives of the Anti-Nazi Federation visited us, and Rabbi Goldberg, of the Committee, spoke to us urging us to cooperate with them in the Boycott Parade their organization was arranging for Thursday afternoon, Nov. 7, at Madison Square. According to our chairman, we have no authority to participate officially in this undertaking unless the Federation secured this permission from the League direct. As individuals, Mrs. Myers urged each and everyone of us to attend, and urge our friends to do likewise in order that the parade be a big one, if at all. Under the banner of the League, however, Mrs. Myers said it was not within her rights to sanction the official cooperation.

She urged Rabbi Goldberger and the lady to have the Federation take this matter up with the League, and that she was willing to abide by orders from headquarters.

Mrs. Myers promised to bring a report from the dinner to Judge Mahoney which the League sponsored. This dinner was given him in appreciation for his open attitude toward <sup>your</sup> removal of the Olympics from Berlin ~~and~~ <sup>or</sup> for ~~the~~ non-participation of the United States therein.

Mrs. Myers urged a deeper interest in the work of the League. Volunteer workers are continually needed at the League's offices for clerical

as well as research work. The ladies were asked to give a day to the service of the League whenever possible. Mrs. Myers ~~she~~ urged a thorough check up on neighborhood stores so make sure their stocks for the Xmas season are not mixed with Nazi made imitations.

She further urged co-operation with the maintenance of the League in the way of helping make the Bridge Tea & Fashion Show a financial as well as a ~~moral~~ <sup>social</sup> success. Mrs. Myers stressed the fact that from previous check-ups, ~~that~~ at every ~~single~~ undertaking, by the League, a Nazi or two are sure to be present to bring back their reports to Yorkville and therefore it is the duty of every

Minutes of the previous meeting accepted as read. Mrs. Myers presided and again reminded the ladies of the Bridge Tea and Fashion Show to take place the following Tuesday. She urged all members to be present and bring their friends.

The secretary read another report from the Research Bureau which keeps us up to date in our Boycott activities. It appears that the Kraft-Phenix Cheese Co. are importing some of their goods from Germany, and also packing some of their numbers in German metal foil. Up until recently they were shipping their goods on German liners, but due to the efforts of Dr. Kalb of the N.J. division they have switched to the Holland-Amer Line. They have promised to cut down on German importations and eliminate them entirely in the future.

POLYdor phonograph records are made from a Master record imported from Germany, so that whenever a POLYDOR records is sold a portion of the profit goes to Germany.

The League wishes to remind members that it stands ready at all time to help storekeepers or consumers replace any article they find necessary to use or sell, that formerly came from Germany, with a suitable substitute made outside of Nazi Germany.

Mrs. Seligman made a report of having visited Klein's 52 & 10 on Tremont Ave and found a toy telephone made in Germany. She cautioned the owner of the result of a boycott on his store unless he discontinued selling German made mdse. He explained that he did not know it was from Germany and would positively return everyone

He needs a few more machines but since they are made in Germany he does not wish to send there for them, and thought that thru the League and its members he might come across some other manufacturer seeking to dispose of them. Members are requested to bring up this topic to any friends they made have in similar lines.

There were many discussions as to how the Bulletin could be developed into greater power. Mrs. Harris our National Chairman, who supplied us most pleasantly by dropping in on us assumed the Chair and answered all questions addressed to her. Mrs. Harris told us that the League has plans for the Bulletin where it will include a greater list of conditions throughout the world affected by the Nazi. She told us the Amer. Federation of Labor sends the Bulletin to all its constituent groups throughout the United States. Also that the Bulletin is send to Ladies Auxiliaries of the Jewish War Veterans. On the discussion relative to the League offering for sale outstanding books published on the Nazi question and conditions in Germany, she told us that the League has eliminated all things except work on the boycott and they will do nothing else that may cause them to deviate in the slightest. Our boycott means a Boycott of goods-ships and shipping from Nazi Germ ny.

Our meeting was very well attended and our women more enthusiastic then ever with constancy to their cause and new ideas to make it stronger, - for which we thank them.

There being no further business, the meeting was adjourned with all the women running home double quick time, to make up for the extra time they took in asking Mrs. Harris questions.

Report of Card Party, May 21, 1936  
held in conjunction with Friends of Democracy

This affair was held in the main ballroom of the Riverside Manor and gave evidence of success at an early hour. Close to 300 people were present and unusual for most card parties - the players cheerfully laid aside their cards when the guest speakers were announced.

Prince zu Lamenstein spoke both in German and in English and if ever boycott workers were impressed with the sincerity - with the straight from the heart talk - they were impressed this night with the Prince. Naturally his <sup>story</sup> message was one of terror and grief - of a once proud nation subdued and helpless to help themselves. Any attempt to spread a message among themselves is so dangerous the average person is terrified beyond attempt by the fears of spies. Help - real help must come from the outside and the power of the boycott is something everybody can understand.

Herbert Segal spoke next and most of you know him as the author of a

book - Called - A Nation Terrorized - A story of his own experiences in a Concentration Camp - his escape - the imprisonment of his wife and 17 month old baby and finally her release thru influential English friends.

I think one of his most telling remarks, one that shows the conditions in Germany as contrasted here was a comparison of our postal system. There nobody dare write his thoughts freely unless <sup>what</sup> he writes be favorable to the Government. Here one can disagree with the Gov. or the policy of the President. Our letters are not opened ~~not~~ our lives or liberty even remotely endangered.

If our people were more fully aware of these contrast of government - I am sure more would overcome their indifference and work with us against Hitlerism and the infiltration of Nazi Propaganda in the U. S.

Eugene Hugat whom most of you have heard at different times and whom we all admire for his earnestness and willingness to help at anytime called upon, made a startling disclosure that Miss Schmeling - the pacifist expects to

give part of his ~~winner's~~ purse to the Nazi  
Cause here. Mrs. Brigot was urgent in her  
plea ~~the~~ fight faces stay away from this  
fight as a protest.

After this our own Charmion, Mrs. Myers  
stepped onto the dais - looking very charming  
and holding two beautiful bouquets. These

Chairman presided and made the important announcement that in addition to spreading the Boycott which has always been the sole purpose of our existence, we have an additional program - that of fighting Anti-Semitism in the United States. This will be done by publicizing the good points of the Jews, collecting information where anti-Semitism is practiced and developing ways & means to counteract it.

It was announced that Mr. Hereman is no longer with the League - our new secretary being Mrs. Kraver.

Mrs. Furman one of our active members reported on a convention she attended of the League Against War & Fascism. One of the important points she brought out was that women in the smaller cities and communities - know nothing of the boycott - tho interested in it. This

applies to both Jew and Gentile. It therefore becomes the duty of each one of us to bear this in mind and to send our bulletins & other publicity, the League furnishes to relatives or acquaintances outside the City. I hope all members will make note of this & follow it out.

Mrs. Stuberbaum, without doubt one of the most sincere and ardent workers we have then took the floor. She reported that her daughter is now doing in Central America - Cristobal, Canal Zone and that Germany was dumping large quantities of merchandise. We have asked Mrs. Stuberbaum to communicate with her daughter to find a party or agency we can establish connections with & shall certainly try all we can to fight Germany off the Canal Zone.

Mrs. Myers then made the announcement that the League has taken the Adelphi Theatre for Nov. 24. The N.P.H. players are producing Sinclair Lewis' book *It Can't Happen Here*. For those who have not read the book, I wish to explain it is the answer of Sinclair Lewis to those doubting unbelieving people - who when told of the evils of Nazism & Fascism - shrug their shoulders, are not interested & say *It Can't Happen Here*. This book is a story of the U. S. of Conditions as they

are right now, even to a radio priest  
broadcasting & influencing hordes of people. And  
it continues to show how easily an organized  
minority thru oratory & dramatic assembly can  
win the Presidency of the U.S. - & then how in  
the twinkling of an eye - Congress - the Supreme  
Court - these great guaranties of our personal liberty  
are abolished - in place - gangsters - ignorance  
& ruthlessness rule the Country. The Jews of  
course are victims but also are all the liberal  
thinking - outspoken - gentiles. We feel it is a  
play everybody should attend and with their  
children who are old enough to understand.

It was announced. Papers have written  
the League they are no longer importing German  
goods. The League is investigating the soundness  
of this.

We were happy to have Mrs. Rosenblatt  
take the floor. As most of you know she is a  
member of our League & Secy of the Friends  
of Democracy - The German Christian organization  
fighting Nazism here in the U.S. with  
headquarters in Yorkville. She tells us the Friends  
are planning a Weirachtofeuer. It is a  
Christmas celebration - beginning in the afternoon  
with a play - serving coffee etc. or a supper.

with speakers in between - Santa Claus  
at the proper time - in the evening dancing  
& beer. All members interested will cooperate.

Mrs. Selman was then introduced. She  
is a German refugee, having been imprisoned  
on a technical charge of not declaring money  
on deposit in N.Y. banks. Under threats of  
death she was compelled to sign power of atty.  
authorizing the Ger. govt to withdraw the \$36,000.  
on deposit in 3 banks here. No lawyer there  
would defend her because of being Jewish.  
Her Christian husband, thru paying large sums  
in bribery got her released from jail & over here.  
Attorneys are fighting to recover her money. The  
banks defense is they paid out the money to  
save her life altho they suspected it was a  
forced power of attorney. In cases of this they  
refuse to do so - they received death certificates  
from the German officials. Mrs. Selman made  
a very telling statement when she said in this  
country gangsters get the electric chair - & in  
Germany they rule the country.

We hope our women will keep up our  
fight of their own interest & valition and not  
require appearances & stories such as Mrs. Selman  
to shock them into a realization of their own danger.

Mrs. Lehman most generously donated a framed picture of Pres. Roosevelt drawn by the artist Mueller - to be raffled at an appropriate occasion

The first order of business was the most  
important thing before us just now, the Theatre Party  
Nov. 24. Members turned in money for tickets sold,  
and many others took additional tickets. We are  
urging everybody to do their bit as it must be realized  
the 1 year membership fee, barely covers the cost of  
mailing the bulletins. Our group activities have  
some expenses, cards - postage - janitor these are very  
slight - but we should & must make contributions  
to the League - tho they have never made any  
demands upon us. Our entire organization is  
supported by voluntary contributions and tho we  
do not ask this of our members - we do ask their  
full support to this Theatre Party. We made a  
splendid showing last April 1935 at the Hippodrome  
and we again want the Bronx women to head the  
list for the Nov. 24 affair.

Payment of dues was then in order & following members paid 1.00 each

A request has been made that we ascertain  
the corporate standing of Lord & Taylor & Franklin, Inc.  
These two concerns have been purchased by the  
Atlas Corp. The inquiring member mentions a  
rumor that Nazi activities are behind these purchases.  
We are cautioning members to pay no attention  
to this rumor until we get an answer from our  
Research Dept. Another inquiry is whether  
Schwinke Certest <sup>supply</sup> materials are made in the U.S.A.  
<sup>our</sup> Chairman Mrs. Myers made a report of how our  
League exposed a German picture masquerading  
as a French one. UFA the leader of German film  
industry had produced the picture and camouflaged  
it with French trimmings. Mr. Zernic a clever  
worker in our Research Dept. detected the fraud,  
proved his suspicions with the resulting public  
exposure in the N.Y. Times. It is such clever &  
valuable work as this that justifies our existence.

Another good example of League activity is the case of the Arnold Bernstein Lines. The steamship Co is being boycotted in the Bulletin. They have come to the League's office pleading to be taken off the black list - showing they are moving their shipping affairs from Hamburg to Antwerp - and also claiming they receive no subsidy from the German Government. While all this is a step in the right direction, and tho their name may be removed from the Bulletin pending thorough investigation we suggest you use your judgment until the League reports its definite findings.

Mrs. Furman was then given the floor and related an experience more stirring than <sup>any</sup> ~~any~~ group ever listened to. Mrs. Furman became acquainted with the activities of the German Jewish Child Care Agency. She decided to adopt 2 boys orphans but when she saw this boy of 9 - who was one of 9 children ranging in age from 9 to 13 recently brought over she decided to take him into her home. <sup>The boy is 19</sup> ~~but had 19~~ <sup>like 9</sup>  
The parents of the boy are living but they have voluntarily relinquished their child and sent him out into a strange world, rather than he <sup>should</sup> remain with his parents in Germany. I am sure you all realize it was not an act of selfishness in sending

At the school the Jewish child is a victim of assault and outspoken derision. This little boy could not stop speaking of the richness of the butter & milk in this country. We are fortunate in having so noble a woman among us as Mrs. Furman. She is an inspiration to re-double our fight against the savages who war on little children.

Mrs. Furman told her experiences in trying to sell tickets to Kaplan Bros. Our sympathy goes out to Kaplan Bros. who are daughters deluged by every activity their customers belong to. Nevertheless they bought 2-1.50 tickets. Mrs. Furman is so endlessly sincere nobody can deny her & get away with it. We wish her good health & long years of active work in the cause of humanity.
