Recent Nazi drive against Jews in Germany is timed to try to take the minds of the "populace" off of their own suffering - hunger. Also of the fight put up by Czechoslovakia. If all European countries had similar guts, there would be no Nazi menace.

The first contingent of Catholic Nuns, refugees from Naziland, arrived in the "Land of the Freo" last week. Hitler barbarism makes no distinction as to race, color or creed.

Quoto from Winchell's column - "Hitler says he stands for civilization but why does civilization stand for Hitler".

As a result of selling Nazi made merchandise under the guise of an American product, the United American Bosch Corp., of Springfield, Mass. is in the "Dog House".

Recent press headline - "Reich trade continues to drop despite anschluss".

Synthetic raw material are being substituted in increasing amounts by the Nazi government. These "Ersatz" products are of inferior quality and much more expensive than the "normal" article. How would you like a little sawdust in your bread - or fish as a substitute for white of eggs?

Latest Anti-Semitic fountain is spouting at Tompkins Corner, noar Peckskill, N.Y., allogodly under the guidance of one, N.W.Rogers, a former magistrate, assisted by Nazi spy "fugitive" Dr. Ignatz Griebl.

Incidently the source of most of the Anti-Semitic propaganda being disseminated from California has been traced to an ex-convict, reputed to be on the payroll of Nazi Gormany.

Do not be misled by the recent headlines indicating

Hitler ordered Germans in this country to discontinue membership
in the "Bund" and other Nazi groups here. The following editorial
from today's New York Post indicates what is probably the facts
behind Hitler's statement: "quote"

## A TYPICAL NAZI FRAUD

If any optimist believes that Hitler's order to Germans living in the United States to stay out of the Amerika-Deutsche Volksbund means a cossation of Nazi propaganda and organization in this country, said optimist ought to have his head examined. Hitler's "order" is a fraud on its face. Nazi propaganda and organization in the United States will go on.

The Nazis won't give it up. The belief that all persons of German descent, no matter where they live or whether they are naturalized foreign citizens or not, are still Germans is a central tenet of Nazism. What has happened is simply that this particular organization, this unspeakable Welksbund, has been in too many clashes with local authorities, with the American Legion, with American liberal opinion. Therefore Hitler stages his new "order" for the special benefit of our State Department.

But the order applies only to non-naturalized Germans in this country. American citizens of German descent are not affected, and many, if not most, of the bund members are naturalized. In Berlin there still stands the huge Foreign Organization of the National Socialist Party (the NFSO), under Ernst Bohle, whose job it is to organize all German citizens abroad into a "foreign province of Germany," Another Berlin organization, the People's League for Germanism Abroad, organizes Germans who are subjects of other countries.

By Bohle's order, as Otto D. Tolischaus explained recently in the Times, all Germans abroad are National Socialists, and counted as such. There is a regional office for North America in the NFSO headquarters in Berlin; consular attaches and "cultural representatives" travel everywhere to organize these members of German's "foreign province"; all Germans abroad are called on "to fight and propagandize every day" for National Socialism; the official publication, Rheinfront, declares:

"Primarily we are not citizens of states but racial comrades."

What price Hitler's "order"?

Please pass this on to your membership as well as to comrades of other American veteran organizations.

ANTI-NAZI LEAGUE CHARGES CONTINUED PUBLICATION OF GERALD L. K. SMITH'S "CROSS AND THE FLAG"; SMITH CHEERS FOLLOWERS ON BASIS OF ELECTION RETURNS

The Nor-Sectarian Anti-Nazi League yesterday released photostatic copies of a post-card mailed out November 4 to his followers by Gerald L. K. Smith, the Michigan rabble-rouser and associate of the late Huey Long, in which he indicated the continued publication of his "Cross And The Flag", which was included in the indictments of subversive individuals and publications presented by the Department of Justice to the Washington Grand Jury investigating subversive activity.

Smith, whom the League described as "one of the nation's most dangerous native Fascists", also rejoiced over the "nationwide repudiation of New Deal bureaucracy". Smith was an unsuccessful candidate for U. S. Senator from Michigan in the recent election, running against the Democratic and Republican candidates. The latter was elected.

The text of the post-card follows:

"Dear Subscriber:

"The current issue of THE CROSS AND THE FLAG will reach you in a few days as a combination October-November issue. The pressure of responsibilities has caused the delay.

"We are all rejoicing over the nationwide repudiation of New Deal bureaucracy and over the fact that the American people have expressed themselves in no uncertain terms in favor of the preservation of our American way of life.

May God richly bless you.

ANTI-NAZI LEAGUE WIRES PROTEST TO SENATORS ABSENT
AT ANTI POLL-TAX BILL SESSION; URGES SUPPORT

The Non-Sectarian Anti-Nazi League during the Wednesday afternoon session of the Senate sent wires to all those Senators whose reported absence from Washington has helped make possible the obstruction of any vote on the anti poll-tax bill, pointing out that "a filibuster is in itself conclusive evidence of a planned attempt to block the know will of the majority of the American peeple."

The text of the wire, signed by Prof. James H. Sheldon, administrative chairman of the League, follows:

"We use your immediate presence on the floor of the Senate to support the anti-poll tax bill and to vote for a rule of cloture needed to prevent threatened filibuster. A filibuster is in itself conclusive evidence of a planned attempt to block the known will of the majority of the American people and thus to subvert the fundamental principle of democracy. To permit such tactics in wartime holds up our whole system of government to ridicale and strengthens the arguments of our totalitarian enemies."

HON. HERMAN HOFFMAN, ANTI-NAZI LEAGUE HEAD AND CRIMINAL BAR PRESIDENT, RESIGNS FROM AMERICAN BAR ASSOCIATION IN FROTEST OF RIVERS EXCLUSION;
ASKS LAWYERS SUPFORT HIS POSITION

Hon. Herman Hoffman, Chairman of the Board of Directors of the Non-Sectarian Anti-Nazi League and President of the New York County Criminal Courts Bar Association today demanded that the American Far Association immediately reverse its position in refusing to admit to membership Hon. Francis E. Rivers, Assistant District Attorney of New York County and leading Negro lawyer. "I have valued my membership in this Association for many years, but its action in this instance will require my own resignation as a public protest", said Mr. Hoffman in his letter.

Action by the Anti-Nazi League's Chairman came following disclosure last week that the American Bar Association had failed to accept the membership of Assistant District Attorney Rivers, because of the latter's race. Rivers has specialized in homicide cases for the New York County District Attorney's office since 1938, is a Yale University graduate and a veteran of the Argonne and other battles of World War I.

"In times like these", Hoffman declared, "any action of a great responsible body which is indicative of a lack of harmony between any of the major groups of people who constitute the United States of America, is an action which necessarily brings aid and comfort to our enemies. The American Bar Association is not a mere club or a social organization; on the contrary, it represents — or is at least assumed by the public to represent — the membership of the bar of this country and thereby all those charged by profession with the operation of the machinery of justice."

"I am addressing a copy of this letter," Hoffman statement continued; "to the Presidents of the Bar Associations of the principal cities of the United States and to other leading lawyers, in the hope that they will join me in requesting that you take every possible step to see to it that the American Bar Association acts as all good citizens can rightly expect it to act in this matter."

Full text of the letter follows:

"I have read with a great deal of trepidation the accounts carried in the metropolitan press today concerning the failure of the American Bar Association to approve the membership of Hon. Francis E. Rivers, the respected Assistant District Attorney of New York County.

"In these times any action of a great responsible body which is indicative of a lack of harmony between any of the major groups of people who constitute the United States of America, is an action which necessarily brings aid and comfort to our enemies. The American Bar Association is not a mere club or a social organization; on the contrary, it represents — or is at least assumed by the public to represent — the membership of the bar of this country and thereby all those charged by profession with the operation of the machinery of justice. Such a responsible body cannot afford to create, for one moment, the impression that it excludes from its membership any person uprightly devoted to the Constitution of the United States and to the principles of humanity and justice for which this Republic stands, merely because of the accident of color.

"In his annual message to Congress, a few days after the attack on Pearl Harbor, President Franklin Roosevelt said:

""We must guard against division among ourselves and among all the other United Nations... Hitler will try again to breed mistrust and suspicion between one individual and another, one group and another, one race and another, one government and another.

It is my hope that no voice from the great profession of the bar may be raised, and no step taken either by action or inaction, which might give assistance to our enemies in this technique of division, or in an effort to weaken the principles on which America has been built.

"I therefore strongly urge upon you that your Association immediately accept the membership application of Hon. Francis E. Rivers.

Mr. Rivers is a graduate of Yale University, in the class of 1915, where he was elected to Phi Beta Kappa, in recognition of his high attainments in scholarship. He is a graduate of the Law School of Columbia University, in the class of 1922, and has been Assistant District Attorney of New York County, engaged in the successful prosecution of homicide cases since January 1, 1938. He was elected a member of the New York General Assembly in 1930, and is an honored member of the Association of the Bar of the City of New York and of the New York County Lawyers Association. During the First World War he fought at the Argonne as a lieutenant of machine—gunners. He was recently made a member of the War Committee of the New York City Bar Association, which represents every important unit of the bar in this great metropolitan area. In terms of character, ability and success in the legal profession, as well as the esteem in which he is held by the entire community, it is difficult to find any person better qualified for membership in your Association.

"I have valued my membership in this Association for many years, but its action in this instance will require my own resignation as a public protest.

"I am addressing a copy of this letter to the presidents of the Bar Associations of the principal cities of the United States and to other leading lawyers, in the hope that they will join me in requesting that you take every possible step to see to it that the American Bar Association acts as all good citizens can rightly expect it to act in this matter.

FASCIST POLITICAL PLOT HERE REVEALED BY NON-SECTARIAN ANTI-NAZI LEAGUES
DISCLOSURES CLIMAX MONTHS OF INVESTIGATION

DICTAPHONIC RECORDINGS OF ATTEMPTS TO BRIBE LEAGUE REPRESENTATIVES PLAYED TO PRESS

Sensational evidence of a plot by native American pro-fascists to form an organized political movement to be inaugurated shortly by a smear campaign against anti-nazi groups and leaders throughout the United States, was today revealed by the Non-Sectarian Anti-Nazi League which, at a press conference in its offices, 165 West 46th Street, played dictaphonic recordings of attempts by a secret agent to bribe League representatives to steal information from its files concerning individuals indicted by the government for sedition and for attempting to undermine the morale of our armed forces.

The recordings were obtained through a dictaphone, installed in a mid-town hotel room, in which the conversations between the agent and League intermediaries took place, during which substantial sums of money were on several occasions paid as "bribes".

According to officials of the Anti-Nazi League, which, in a few months will celebrate its tenth year of anti-nazi activity, the agent was only a "link in a giant network with centers in Washington, Chicago, Detroit, and New York."

A bizarre plot, which might have been part of an Alfred Hitchcock scenario, was unfolded through 52 recordings and a score of assembled affidavits of witnesses. Completely unaware that the League had been apprised, from the beginning, of his attempts to bribe League employees, James C. Dunn, the agent, who gives the Cornish Arms Hotel as his local residence, took them into his confidence and talked for hours of the plans of his employers to develop a native Fascist movement based, according to the League, upon the presumably defunct "America First" Committee, the remains of pre-war pro-appeasement elements, and even more sinister components.

The plot moved shead on several fronts

l. Secret investigators were employed to spy upon pro-democratic and anti-nazi organizations, in a dual attempt to discover what information they possess concerning anti-democratic activity, and, in addition, to obtain any data upon their membership, which could be twisted into a smear campaign against all anti-fascist forces.

The Anti-Nazi League is only one of the groups which was made the subject of an investigation by the paid spies.

- 2. The group, whose backers at present can only be identified as consisting of the "'America First' clique in Congress and certain influential industrialists", intends to pervert whatever information it has been able to dig up concerning anti-fascist groups into a smear attack, in an attempt to discredit not only these patriotic groups themselves, but the entire government and war administration as well.
- 3. An attempt will be made in Congress by certain "isolationist" members to "investigate" the Department of Justice for its action in indicting 32 individuals and many organizations and publications for sedition, on the grounds that the prosecutions were the results of "pressure" by patriotic organizations. Many of the senators and congressmen instrumental in asking for a probe of the Department were linked to the individuals and groups soon to be tried in Washington.
- 4. At the trials of the accused seditionists, information which these secret agents are seeking to accumulate will be given an anti-Semitic twist, in an attempt to convince the American public that private organizations with so-called "Jewish" support, were responsible for the prosecution individuals of the 32/now under indictment by the government. This will, of course, be picked up and broadcast over the Nazi short-wave radio.

According to the League, the ramifications of the affair are nation-wide and involve several of the most important leaders of the "isolationist" bloc in Congress, as well as industrial leaders who were the secret backers of the indicted "America First" Committee.

The story which culminated in today's disclosures by League officials, began several months ago, when an investigator, employed by the League to report on pro-fascist meetings, turned traitor and began sending reports on the League's activities to individuals in Washington and Detroit. The League, which had known of the activities of the investigator, Frank Evans, of 25 East 39th Street, for some time, did not reveal \$\frac{1}{2}\$ts knowledge to him.

Early in November, another employee of the League was contacted by Dunn, who explained that he had been sent by Evans to ask this employee to obtain information from the League's files. Pretending to be amenable to a bribe, the League employee advised officials of what had happened, and arranged for another meeting with Dunn in his hotel room a few nights later.

A dictaphone was hidden in the room, and a recording apparatus set up in an adjoining suite.

The conferences which took place on that evening, and again several nights later, showed that according to Dunn's own statement, he was working for William Griffin, New York publisher recently indicted for sedition, who is soon to go on trial with the 31 other defendants, in Washington.

Dunn apparently believed that the League possessed information concerning Griffin's activities which he wanted the League employee to steal, or if impossible to do so himself, to obtain it by, in turn, bribing another member of the League's staff. A League representative was assigned to pose as a file clerk who could be induced to filch the files which he wanted.

In addition, Dunn was particularly interested in obtaining the names of of members/and contributors to the Anti-Nazi League, on the apparent assumption that it would be possible, in the near future, to smear these individuals along with anti-mazi groups.

As the conversations developed and more meetings between Dunn and the League intermediaries took place, Dunn admitted that he was working directly or indirectly for several highly-placed individuals who were about to form an organized political movement, anti-Semitic in nature, which would unite isolationist and pro-hazi forces in an attempt to swing the 1944 elections.

According to the secretly recorded admissions of Dunn, plans for the organization have already matured, with offices scheduled to be set up in every major city in the country.

Although the new group would not admit that it was in any sense profascist, and would even disown such groups as the "Christian Front", actually, it would embrace the members of the "Front" and all other subversive groups which were active until Pearl Harbor.

Dunn and Evans, both working in conjunction with Joseph P. Kamp's so-called Constitutional Educational League (also under indictment in Washington), grew ever more active in their attempts to obtain information from and about local anti-fascist groups, which would be used in the smear campaign

intended as a prelude to the formation of the new political organization.

The League, of course, notified all groups concerned to beware of either of these individuals, or of attempts which their agents might name to break into files, as Dunn had suggested doing in the case of the Anti-Nazi League.

The disclosures today came after weeks of investigation and counterespionage, during which Dunn and Evans and their associates were under constant observation and their activities continually checked.

According to Prof. James H. Sheldon, administrative chairman of the Anti-Nazi League. "It is imperative that the public be awakened to the danger of a fascist political movement in this country without further delay.

"The time has come for the American people to be made cognizant of the trap which is being set for them by a selfish minority of pro-fascist individuals who, under the guise of isolationism, are trying to lead us, if not into the camp of Hitler, certainly to a pro-fascist form of government which would make vain our sacrifice of thousands of lives and billions of treasure in winning this war."

ANTI-NAZI LEAGUE URGES JUSTICE DEPARTMENT
TO QUICK ACTION IN TRIAL OF SEDITION INDICTMENTS;
CITES RENEWED PROPAGANDA ACTIVITY OF SMYTHE AND OTHER DEFENDANTS

Edward James Smythe, one of the 34 persons under indictment in connection with the sedition charges, in Washington, D. C., has apparently not profited from 32 months spent in jail before he was recently released on bail. He has formed a so-called "National Council for Civil Liberties", which yesterday started to distribute a bulletin which commences: "34 of your fellow Christian Americans are about to go to trial in Washington, D. C., charged with 'SEDITION'; their only crime was that they loved their Country too much..." The leaflet goes on to solicit funds for the defense of Smythe and his fellow-defendants, and for expanding his propaganda.

The bulletin follows the usual Nazi or "Christian Front" technique, in charging the authorities responsible for the conduct of the war with "plots" and "tyranny". All this, as usual, is blamed on the Jews and Russians. Particularly violent passages are directed against President Roosevelt, whom Smythe insists upon referring to as "Mr." Roosevelt, and the "plot for a fourth term".

Smythe's new leaflet follows the same line as that already set by remnants of the German-American Bund and "Christian Front" groups, as well as by such isolationist leaders in Congress as Congressmen Hoffman and Bradley, in conjuring up a "plot" with regard to the fourth term, and in singling out Jewish members of the administration for "blame" in connection with their attacks.

Investigators for the League have reported a plan among Smythe and some of his associates to open a "canteen" for servicemen, where these men can come in contact with "wholesome Americanism". Smythe's friends have under consideration an address on 50th Street as the site for the projected canteen.

The Non-Sectarian Anti-Nazi League last evening urged the Attorney General, Hon. Francis Biddle, to accellerate the trial of the 34 defendants in the sedition cases as much as possible, stating that "the propagandists under indictments are now seizing on the publicity attendant on preparations for the trial, in order to get a new audience for their subversive propaganda, and in order to weaken American resolve to fight on until "unconditional surrender" of the Axis has been won. A new low level of propaganda techniques has been

achieved in the activities of these people, who reflect and disseminate in America the established Goebel's propaganda line of setting group against group and race against race".

The League's communication, which was signed by Prof. James H. Sheldon, Administrative Chairman, urged upon Mr. Biddle the desirability of finding some way, through supplementary indictments or otherwise, to compel cessation of this "seditious propaganda", pending the completion of the trials.

Typical excerpts from Smythe's new bulletin follow:

"34 of your follow Christian Americans are about to go on Trial in Washington, D. C. charged with "SEDITION"; their only crime was that they loved their Country to much and were MILITANT crusaders against the CANCER of Communism, JEWISH or RUSSIAN."

"JEWISH-COMMUNISTIC PERSECUTION AGAINST CHRISTIAN AMERICAN PATRIOTS."

"Will you become an active member of the NATIONAL COUNCIL for CIVIL LIBERTIES and donate five dollars or more to the cause of AMERICAN INDEPENDENCE?"

"I went to jail for fighting against COMMUNISM. Spent three and one half months in a HELLHOLE in Washington."

"Mr. Roosevelt must not be given a fourth term. FELLOW AMERICANS UNITE to SAVE THIS GOD BLESSED SOIL FROM SUCH A DASTARDLY PLOT."

"The American Revolution was fought... against TAXATION WITHOUT REPRESENTATION. We are in that very same position to-day. We are taxed to the death, but we have no representation or voice in our Government at Washington, D. C. under Roosevelt and his gang..."

# History of the Toycott:



ONTEMPORARIES cannot properly write history. They are too near the scene. However, we can make some notes from which later historians may gather the facts. Not having seen heretofore even an approximation of the events leading up to the commencement of the boycott, we are hereby undertaking the task.

And we are optimistic that the boycott will make history. We will be disappointed if the Economic Boycott does not displace guns—and battle-ships—and airplanes and chemicals in settling future disputes among nations. The recent conference of nations at Stresa practically decided that a boycott of Germany at present was the only effective means of curbing Hitlerism and its attendant war menace and de-civilizing principles.

Rarely do we read the literature of organizations now interested in the boycott but what they claim credit for having been responsible for the boycott. Newspaper clippings prove that the boycott was originally sponsored by the Jewish War Veterans of the U.S. Most of the organizations now claiming credit originally, and for months, did everything possible to deter us and prevent us from carrying on the boycott. What the J. W. V., suffered before some of these other organizations came to our aid!

During a life-time, we have many ideas. Most of them do not reach the stage beyond an "idea." We all know that ideas without more, usually die aborning. It was interesting therefore, to read recently that a comrade was given a testimonial dinner because he was the "first" to conceive the idea of a boycott. Furthermore, history shows that boycotts have been used for hundreds, possibly thousands of years.

Caesar, Alexander, Napoleon, were the leaders of millions of soldiers. It was their leadership, their aggressiveness, their planning and execution, which won the battles. A group of men without a leader is a mob. The boycott without a leader would be a sham. If it is true that every crisis brings a leader, then the Jewish War Veterans were indeed fortunate in having as its leader, the peerless leader, J. George Fredman, then Commander-in-Chief. If our comrades have any loyalty, if the world-at-large has any unselfishness, they will place the crown of sponsorship and responsibility for the success of the boycott, where it properly belongs, on comrade, J. George Fredman.

We have seen it so many times. One man aggressively, continuously, courage-ously, and above all modestly, "does a job" and immediately it is completed, swarms jump in to claim the credit. George WAS not only the brains, the motive power, the courage of the boycott, he still IS. While most of us lost interest and dropped by the way-side, George has continued to keep up the boycott, unabated, and next to

Samuel Untermyer, is today the leading factor in the success of this movement.

Not that we wish in any way to detract from the great contribution to the cause, of that grand humanitarian, Samuel Untermyer. Once the boycott was in swing we could not have had a more intelligent, in-spired and relentless leader than Mr. Untermyer. As we recall it, Mr. Untermyer's first large contribution to the Boycott Movement was at our National Memorial Services in New York City, in May, 1932. It was Mr. Untermyer and comrade Fredman who went to Amsterdam, in July, 1933, and made the boycott a real world cause. When comrade Fredman found that Mr. Untermyer's organization was better equipped to further and intensify the boycott, he became a director of the Non-Sectarian Anti-Nazi League, and is still is a member of its guiding Executive Committee.

But to get back to the start of the boycott. The first public utterance for a boycott was made by George, on March 19, 1933, at the Astor Hotel, New York, at a meeting of the American Jewish Congress, at which representatives of the American Jewish Committee, Zionists and other national Jewish organizations were present. His advocacy of the boycott met with instant appeal of the large audience, but the frigid opposition of the leaders on the dais.

Feeling that the leaders of Jewry would pussy-foot on the entire Nazi problem, George, without a moment's hesitation, left the hall and called a special Executive Council Meeting for the following night. M.On May 20th, 1933, at the Knickerbocker Hotel, in the presence of the press, George put the J. W. V., unequivocably behind the boycott, and arranged that same evening to hold a mass protest parade in the streets of New York, only two days hence, on March 23rd, 1933.

How hectic those two days were! The story of the boycott and the parade broke in all papers the next morning. Immediately the leaders of the American Jewish Congress tried to have the parade stopped. Ex-Congressman, W. W. Cohen, one of our Honorary Members, who had consented to act as our Marshal, and who happened to be a Vice-President of the Congress, was urged to resign as Marshal and use his influence on us. Congressman Cohen wavered, but like the true and courageous comrade he is, he stuck to the J. W. V. Efforts were made to have our parade cancelled. Influence was brought to bear on Mayor O'Brien not to receive us at the City Hall. Threats were tried. Erroneous stories were given to the press that the parade would not be held. Pressure was brought on comrades, Mendelsohn, Kraditor and others, and for a time even these stalwarts wavered as to whether we might not be on the wrong track. Through it all—George stood adamant. "The parade will go on," said he, "even if I am the only one to march." The night before the parade, several comrades in Manhattan Post urged their comrades NOT to march in the parade—that it would be a "flop."

And as you all know, the parade did go on. And what a spectacle! Millions lined the streets of New York to witness this first impressive protest against Hitlerism. When Mayor O'Brien learned of the popular outpouring, he changed his mind and was happy to review the parade. More publicity was given this parade than any other event, or even series of events in J. W. V., history. In fact it received more space than even the historic flight of Lindberg. The Conservative Literary Digest, Liberty and even European papers carried pictures of it. March 23, 1933, should stand out as a beacon—the day of dates, in our history. From that day J. W. V., became known nationally. Through it all appears the steadfast determination, the organizing ability and guiding genius of comrade, George Fredman—our Napoleon.

From then on events moved swiftly. A protest delivered to the Mayor of New York; another protest urging cooperation from the British Government; a trip to Washington on May 30th, 1933 to President Roosevelt urging his intercession in Germany, a call upon Speaker Rainey and a group of representatives at the Capitol; a resolution by the Board of Aldermen of New York City; by the legislature of New Jersey, and by numerous other municipalities and states, all with the purpose of arousing humane protest against the atrocities of Hitler.

Meantime, the boycott was going on apace. Public addresses nightly; organization after organization solicited to join the boycott; card-board placards, designed, printed by the thousands and put in windows of stores and in offices; the Boycott Stamp designed and printed—ten million of them sent out, and several million used on the outside of envelopes where the world could see them and become familiar with the boycott. Until early in May, 1933, the Jewish War Veterans was waging this battle for the world, ALONE.

At that time the American League for the Defense of Jewish Rights was organized and joined in the boycott. J. W. V., was happy to be of every assistance and cooperation in helping them to get started. It was this organization which was succeeded by what is now known as the Non-Sectarian Anti-Nazi League, of which Mr. Untermyer is President. Other organizations then followed. It was not until August, 1933, however, that the American Jewish Congress officially declared itself in favor of the boycott-almost five months after we had started-and what valuable time was wasted in the interim-what a tremendous foot-hold Nazism had been able to gain in the meantime, and what suffering our unfortunate German brethren had to endure during these five months while these organizations were deliberating, pussy-footing and making up their minds, The worst part of it was, that envious of the continuing spotlight the boycott had brought to J. W. V., these organizations were actually condemning the bovcott, and criticising J. W. V. To-day, THEY "claim credit" for the boycott.

Incidently the main work of the boycott was done by J. W. V. We aroused the world to the necessity and effectiveness of a boycott. Since then the boycott has been progressing mainly on its own momentum. The task to-day is to hold what we have gained and keep the interest in the movement from lagging.

At our Memorial Services, in May, 1933, Mr. Untermyer offered to represent American Veteran Organizations before the League of Nations to compel enforcement on Germany of the minority covenants of the Treaty of Versailles. This offer was transmitted by J. W. V., to every veteran organization in the United States, resulting in hundreds of posts passing resolutions accepting Mr. Untermyer's proposal. The effect of our efforts undoubtedly resulted in arousing the four million American veterans to the perils of Nazism, and their present stand to combat every "ism" which attempts to gain a foothold and spread in extraorica.

Who, that witnessed it, will ever forget that memorable scene at our National Encampment at Atlantic City on July 4th, 1933? Having brought the Jewish War Veterans into international repute—and raised it to the pinnacle of its fame, having aroused the world against the outrages of Hitlerism, and having brought into effective operation the only effective weapon against Hitlerism—the boycott, our peerless leader was urged to accept command for another year. The sacrifice was too much. With tears unrestrained, coursing down his checks, and many of ours, he declined. The sacrifice and the strain were too much. He had averaged 18 to 20 hrs., each day in the cause of J. W. V., and humanity; he had sacrificed his health, his family, his fortune and his profession—for us. He was deserving of a rest, but we lost a LEADER.

Immediately following the Convention, George went to Europe, in company of Mr. Untermyer. In London he contacted the Jewish War Veterans of Great Britain. In France, he inspired the Combattants Juifs. He persuaded the Poles to organize a Jewish War Veterans Association. At the same time he aroused the countries he visited to the necessities of strengthening the hoyeoit. At the International Conference, he ably represented the United States and the Jewish War Veterans and returned home as Vice-President of the World Boycott Organization.

Not for one day since has he neglected to raise his voice, or use his pen in combatting Nazism and intensify the boycott. With Hitlerism seeking to gain a foot-hold in the United States, he has been in the foreground of every battle to stop them.

A detailed chronicle of his activities would occupy more space than this article will permit. In passing, it might be mentioned that Commander Fredman was the inspiring force which resulted in the passage, recently, in the State of New Jersey, of what is known as the anti-propaganda bill—a bill which will undoubtedly curb un-American activities in the State of New Jersey, and probably be copied next year in other states, if not by our Federal Government.

Suffice it to say that Jewry should be grateful that they have had George Fredman as a leader during the past two and one-half years—the darkest in the last century or two. His comrades in Jersey City Post, No. 10, are proud of his achievements and honored in the knowledge that George came from within our midst, and like Judas Maccabeans, was there to lead our fight. He is still there in the forefront representing Jewry the world over, fighting for their rights and for their lives. A truer and nobler son of Jewry was never born.

May we hope that our great organization—the Jewish War Veterans of the United States, who owe so much to George will honor him in some manner that will proclaim to the world-at-large that we are not entirely unmindful of his great sacrifices in our behalf.

It should now be emphasized that the Nazi party numbered about 5% of the population of Germany when it was ready to take over that country and the Communists in Russia had a far smaller number than 5% of Russia's vast population when it seized power. In this country it is believed that about 20% are passively involved while the majority perhaps because of widespread mis-information or lack of any information are completely negative.

We are told that despite high employment the hate organizations are growing and their publications becoming fatter. Gerald L.K Smith on a recent tour played to packed houses in Texas, Arkansas, Mississippi, and Alabama. The Klu Klux Klan is publicly and vigirously active in Georgia, Alabama, Mississippi and other states. In areas where the Klan does not operate under its own name, front organizations are active, some anti-Jewish, some anti-Catholic some anti-Labor, some anti-Negro

In order to really be determined to fight these un-American termites, one must first clearly understand how dangerous they are and what a threat they represent to our American ideals and our individual liberty.

The Congressional document defines fascism "as the seizure and control of the economic, social and cultural life of a nation by a small group which suppresses free speech, free worship and public meetings. It requires blind obedience to a leader and is necessarily militaristic and nationalistic.

During the war, most of the hate groups, the shirt groups and the hooded groups were driven underground, but since the end of the war as after all major wars, these groups and new ones have emerged and according to substantiated evidence are growing menaceged and It is our duty to do our part in fighting the growing menaceged.





# RULES

# GOVERNING THE NATIONAL CONVENTION

# OF THE NON-SECTARIAN ANTI-NAZI LEAGUE

- 1. All delegates recognized by the Credentials Committee as accredited delegates shall be given delegate cards and badges, and shall be allowed to participate in the proceedings of the convention and to vote on all matters coming up before it.
- 2. Roberts Rules of Order shall guide the proceedings of this Convention.
- 3. Discussion on any single matter before the convention shall be limited to five minutes to each delegate.
- 4. No delegate shall be allowed to speak a second time on any one subject until all delegates who have indicated their desire to speak have been given an opportunity to do so.
- 5. Appeals from the decisions of the chair shall be limited to five minutes.

# "CHRISTIANS UNITE TO PUSH BOYCOTT OF NAZI GERMANY"

"Inasmuch as the Nazi persecution of Jews and Christians violates and threatens every principle which as Americans and Christians we hold most dear, we feel we must protest not only by word but by deed.

"We therefore pledge ourselves to do nothing, either directly or indirectly, which can aid the German Government as long as it maintains three principles which lie at the very heart of Nazi doctrine: First, violation of religious freedom; second, racial persecution; third, glorification of war and inculcation of race hatred into the minds of little children.

"As long as these doctrines prevail we pledge ourselves not to travel on Gorman ships, knowingly buy German goods or visit the territory of the Third Reich.

"We pledge this not in hatred of the  $G_0$ rman people, but because since we are not allowed to communicate with them by word we can only open their eyes by letting our actions speak for us."
