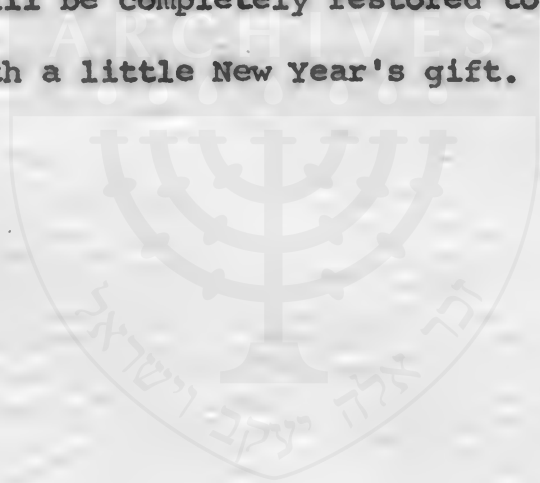



We must make and forthwith set up an appointment with Marshall Napshin for the purpose of providing me personally with some bookkeeping service which you and I agree is several years overdue.

Here are some thoughts which I have in mind. First, we should try to eliminate as far as possible many hours of work which you, in the first instance, have at income tax reporting time on my income tax report and, second, we should reduce to the minimum the number of hours that the accountants have to spend in assembling from the hodge-podge which we throw at them ¹to report.

1. That there be ledger sheets for every account on which I do business; that every bank where I make loans and pay interest be carried separately on a ledger sheet; that there be posting regularly not less than once a month; that the posting be not only to the account directly involved but that we post to the various categories which the accountants need from which to make their income tax reports.

For example, if I pay interest to George Widmer on the note which I owe him as the balance of the purchase price on the property near 67th and Quivira, the posting should be made both to the Widmer account and to the interest account, or if I receive interest on the Cliff House Motor Hotel, that that be posted to the Cliff House Motor Hotel and to an interest received account.

2. Other accounts which the accountant needs are my automobile expense account; my club dues; my general business expense; the business taxes and insurance paid, etc. These should be posted regularly. The same is true of dividend accounts; my charitable contribution account; my medical expense; my alimony payments.

What I am trying to do is have a system of bookkeeping which will reflect immediately at the end of each posting period the exact amount which has been paid or received on all of my business ventures and at the same time provide a cumulative knowledge of what we have been doing up to date.

Please arrange a meeting with Mr. Napshin on this matter without delay. I have sent him a copy of this memorandum so that he may know what I have in mind when you call him.





TEXT OF RESOLUTION ON SOVIET ANTI-SEMITISM
September 25, 1963

S. Res. 204

Introduced by
Senator Abraham Ribicoff

Co-sponsored by:

Whereas the Senate of the United States deeply believes in freedom of religion for all people and is opposed to infringement of this freedom anywhere in the world; and

Whereas abundant evidence has made clear that the Government of the Soviet Union is persecuting Jewish citizens by singling them out for extreme punishment for alleged economic offenses, by confiscating synagogues, by closing Jewish cemeteries, by arresting rabbis and lay religious leaders, by curtailing religious observances, by discriminating against Jews in cultural activities and access to higher education, by imposing restrictions that prevent the reuniting of Jews with their families in other lands, and by other acts that oppress Jews in the free exercise of their faith; and

Whereas the Soviet Union has a clear opportunity to match the words of its constitutional guarantees of freedom of religion with specific actions so that the world may know whether there is genuine hope for a new day of better understanding among all people: Now, therefore, be it

Resolved by the Senate, That it is the sense of the Senate that persecution of any persons because of their religion by the Soviet Union be condemned, and that the Soviet Union in the name of decency and humanity cease executing persons for alleged economic offenses, and fully permit the free exercise of religion and the pursuit of culture by Jews and all others within its borders.

Dear Mr. Cohen:

How do we decide how much a contributor can reasonably be expected to give to the annual Jewish Federation campaign? This is one of the more persistent questions confronting our campaign leadership -- and it is becoming increasingly important as communities search out areas for campaign improvement.

Our General Assembly Program Committee has scheduled a workshop session devoted exclusively to questions of the "Givers' Portfolios -- The Federated Share."


How much can a contributor be expected to give to the Jewish Welfare Fund -- to other Jewish causes -- to other philanthropies? Who discusses his portfolio of giving with a contributor -- when? What are the most productive ways of upgrading giving levels?

This workshop is scheduled for Friday afternoon, November 13, from 2:45 to 5:00 p.m. at the Chase-Park Plaza Hotel in St. Louis. The emphasis at the workshop session, incidentally, would be on an informal review of the issues (rather than on formal addresses) -- with a moderator who would call on the members of the panel for their views and comments.

As advance material for the workshop, we are circulating a questionnaire to a sampling of communities. This questionnaire will give us viewpoints on how contributors distribute their gifts as between the Jewish federation, other Jewish causes, and other philanthropies. This material will be available to the participants in advance of the workshop session.

Knowing the thoughtful attention you have given to these questions in your own community, and the importance of effective guidelines for all communities, we are understandably eager to have you serve as chairman of the panel -- and we do hope you will let us know within the week that you will accept.



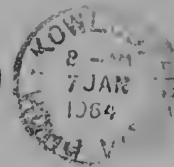

PROPOSED FINANCING PLAN

I would suggest that the syndicate which has expressed interest in coming into the plan put up a total of \$105,000.00, as follows:

Capital Stock	\$5,000.00
10-Year, 5% int. bearing note	\$100,000.00

I propose that the 5% interest on the note be on an annual basis, with quarterly payments of both principal and interest, and by this I mean the first year's interest would be \$5,000.00 and would be payable quarterly \$1,250.00 and the principal payment would be \$2,500.00. The second year the interest would be \$4,500.00, making the quarterly payment \$1,125.00 each, plus \$2,500.00 to be paid on the principal.

This would pay the note in ten years, and would give the syndicate a return of \$27,500.00 interest on an average investment of \$50,000.00.

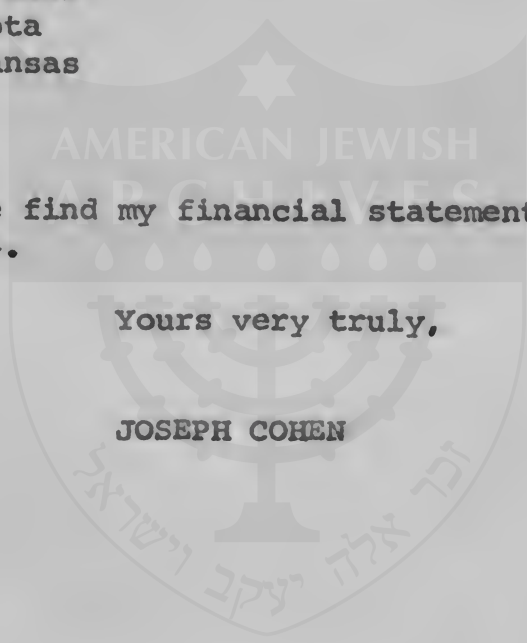

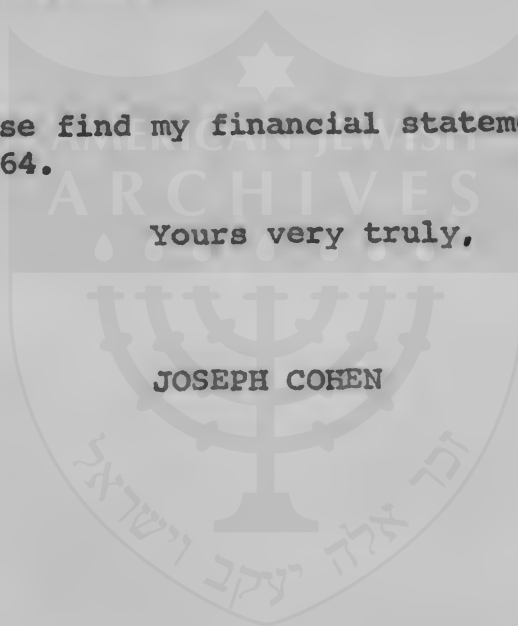

Dear Uncle Joe,

I'm ashamed to say that I've lost track of our last correspondence. These first few weeks of school have ~~completely~~ kept me jumping every minute. I'll try to bring you up to date on us.

My research work this summer was quite fruitful, and I was able to complete my thesis by the middle of August. About the last week in August Maureen, Lauren, and I drove out to Durham, N.C. to see the Duke University medical center. It is a terrific place, and we are thinking seriously of going there for the seven years of training (including internship) that thoracic surgery requires. After leaving Duke we drove peacefully through the Smoky mountains for several days, enjoying the pleasant change from the flatlands to which we are accustomed. Then we went over to Dallas for about ten days. We returned home to N.O. just in time for the beginning of school. Incidentally, the school was kind enough to let me charge my tuition of \$700; we would certainly appreciate \$500 from the trust to defray it.

Lauren is a living doll and keeps Maureen constantly busy. She now crawls and walks (holding on) with great facility all over the house, and nothing is safe that lies within two feet of the floor. She is saying DADA, NANA (for Mama), and countless other nonsense syllables. Her recent accomplishments include clapping hands and waving BYE BYE with a coquettish smile. We are getting copies of some recent photos for you.

I am spending this first six weeks of school on a medicine ward at Charity, and as providence would have it, it is the ward of George Burch, the chief of the department and one of the top cardiologists in the country. It's really a challenge to match wits with him on early morning rounds, and I'm enjoying it thoroughly. Actually it wasn't providence at all; I asked for his ward.

Regarding internships, I am applying to Tulane, Duke, Southwestern, and either Kansas or Washington in St. Louis. My advisors tell me that I have an excellent chance to get my first choice (thanks to my grades, 17th of 124, and recommendations two of the top staff surgeons and my research preceptor. So, all we must do is decide. Presently we are leaning toward Duke with Tulane as second choice. Naturally the folks are extremely anxious that we choose Southwestern in Dallas. I'm not entirely satisfied that it is what I want, in terms of training,

and probably of equal importance is our reluctance to live at this time in Dal as where we would necessarily be in a more dependent relationship with the folks. I'm afraid ~~it~~ will be quite a blow to them if we elect to go anywhere but Dallas or Tulane, especially because the differences between the training at these various places are rather subtle and not readily apparent or explicable to laymen. After all Southwestern is a large charity hospital affiliated with a medical school with an active teaching and r search program, but to me there are important differences, and as we discussed im June, one must follow his own destiny. *I suppose.*

We hope this letter frinds you and all the family well and happy, and we hope you'll find time to write us real soon.
